I. Entering into new, enemy territory. Attacks can happen before, during, and after trip.

- A. Why are we being attacked?
- B. How are we being attacked?
- C. How do we battle against the attack?
- D. Our mindset/attitude/paradigm in this season and during times of attack.

II. Why are we being attacked?

- A. Open doors - the enemy is a legalist. Never go to war against your adversary unless you have first been to court.
- B. 1 Peter 5:8 - "Be of sober spirit, be on the alert. Your adversary (anti-dekos is "one who brings a lawsuit"), the devil, prowls around like a roaring lion, seeking someone to devour."
 - 1. Enemy cannot devour at will; he has to discover a legal right to do so, that's why he is "seeking."
 - 2. What is he seeking? He is seeking where he has to legal right to bring accusation against us ("open doors").

III. How are we being attacked?

- A. Rev. 12:10 - "Then I heard a loud voice in heaven, saying, 'Now the salvation, and the power, and the kingdom of our God and authority of His Christ have come, for the **accuser of our brethren** has been thrown down, he who **accuses** them before our God day and night.'"
- B. How does the accuser bring a case against us? Three areas - we will need to deal with all 3 areas before, during, and after Cambodia trip.
 - 1. Sin - also has to do with motive
 - 2. Transgression - stride or step across a line; activity against God
 - 3. Iniquity - sin in the bloodline
 - a. See a pattern? Almost always a curse attached to it
 - b. If enemy cannot get us to sin or transgress, he attacks us in our mind (battlefield).
- c. Iniquity does 4 basic things:
 - 1.) Gives the enemy the right to tempt you in a given area - almost all strongholds come from an iniquitous root.
 - 2.) Iniquity will fashion your identity and the way you think about yourself if you let it. (Is. 6 - whoa is me...change happens after iniquity is removed.
 - 3.) Iniquity not dealt with will deter you from your destiny. (Psalm 139:16 - scrolls written in heaven about me before I was born. When I was born, I was a scroll that landed out of heaven in a body that is connected to a bloodline, and the enemy uses

the iniquity of that bloodline connected to that body to pull you off course from what you were originally meant to accomplish.

- 4.) Iniquity in the bloodline is used against you to build cases against you in the courts of heaven (2 Sam 21)

IV. How do we battle against the attack?

- A. Never go to war against your enemy unless you have first gone to court.
- B. How do we approach God?
 1. Approach God as Father - it's about meeting our own needs.
 2. Approach God as Friend - approach for needs of others - intercession.
 3. Approach God as Judge - come to Him as Judge when dealing with our adversary. (Luke 18:1-6)
- C. Courts of Heaven
 1. God the Judge
 2. Satan the accuser
 3. Jesus, our advocate
 4. Us, the brethren, the accused
- D. General steps - BE LED BY THE HOLY SPIRIT
 1. Come before the Lord and repent of any known sin/transgression
 - a. Repent for times you have spoken evil against others
 - b. Forgive those who spoke evil against you; then bless them.
 - c. Condemn words spoken against you
 - d. Call into being what is written in the books of heaven about you
 2. Come before the Lord in regard to specific issue
 3. Ask Holy Spirit to examine your life and your bloodline and show you any iniquity where the accuser has made a case against you or anyone in your bloodline. Receive what He shows you BY FAITH!
 4. Come before God the Judge and agree with the accusation against you or your bloodline (confession).
 5. Ask your advocate, Jesus Christ, to cover you, your bloodline, and the iniquity with His blood, and ask forgiveness on behalf of ancestor.
 6. Rev. 12:10-11 - The blood of the Lamb is the most important weapon we have in our arsenal. IT IS ALWAYS ABOUT REPENTANCE AND THE BLOOD OF JESUS!
 7. Prophecy what Jesus is saying about you! Prophecy what is written in your heavenly book!

V. Our mindset/attitude/paradigm in the season and during times of attack.

- A. We have the victory! When going into the courts of heaven, we are not trying to get God to render a verdict...the verdict has already been rendered. We are actually seeking to get the verdict that has been rendered executed into place because of what the blood of Jesus has done. When we meet the criteria of repentance and confession, we get the benefits of the verdict that has already been rendered.
- B. We are not victims! This is an OPPORTUNITY for growth....going to the next level....going from glory to glory....because when the iniquity is exposed, it can be dealt with through confession, repentance, and the blood of our Advocate, Jesus!
